The Vendor covenants, promises and agrees to and with the Purchaser

that the the School House is now in the possession of the Purchaser is situated at or near Lot A, Section 35, Cortes island, Sayward District, Plan 4223 lying to the South of a straight boundary joining points on the Westerly and Easterly

boundaries of said Lot distant respectively One hundred and thirty-two (132") from the North Westerly and North Easterly corners of said lot, as outlined in red on the attached Appendix.

- that the Vendor is now rightfully and absolutely possessed of and ENTITLED to (b) the said chattels assigned.
- that the Vendor has in itself GOOD RIGHT TO ASSIGN the said chattels to the (c) Purchaser in the manner aforesaid.
- that said chattels are FREE AND CLEAR of all charges and encumbrances of (d) every nature and kind whatsoever.

AND IT IS EXPRESSLY AGREED between the parties that all grants, covenants, provisos and agreements, rights, powers, privileges and liabilities contained in this Indenture shall be read as made by the respective parties, and their respective heirs, executors, administrators, successors and assigns, the same as if the words heirs, executors, administrators, successors and assigns had been inscribed in all proper and necessary places; AND wherever the singular or the masculine pronoun is used, the same shall be construed as meaning the plural or feminine or the body politic or corporate where the context or the parties so require, and where a party is more than one person, all covenants shall be deemed to be joint and several.
